We teach adults the reading and other English language skills they need to provide for their families and contribute to the well-being and prosperity of our community. In addition to one-on-one tutoring, we provided the following classes: beginning literacy, conversation, writing, pronunciation, civics, and computer literacy. Our workplace program targets employees in low paying jobs and our parent outreach program provides classes and one-on-one tutoring to adults at three schools their children attend.

 With 164 volunteer tutors, we taught English as a second language to 212 non-English speaking adults and basic literacy skills to 19 native English-speaking adults. These volunteer tutors provided 10,963 volunteers hours of instruction, instruction preparation, travel, professional development, and tutor training valued at over \$314,000. An additional 77 volunteers donated 4,379 hours (valued at over \$125,000) to further the literacy program. Over the past several years, we have developed a workplace literacy program partnering with local businesses to support their employees through weekly classes to help them improve their English language proficiency and gain everyday life skills. We are currently working with the restaurant and hospitality industry and plan to expand to other industries as we continue to develop this program. Adult learners achieved the following outcomes this year: got a job or a better job, improved employability skills, received GED, entered other education and/or training, improved scores on a standardized test, advanced levels in curriculum series, obtained citizenship, registered to vote or voted for the first time, obtained a driver's license, increased involvement in community activities and children's educational activities, attained consumer skills, wellness and healthy lifestyles, and other personal goals.
